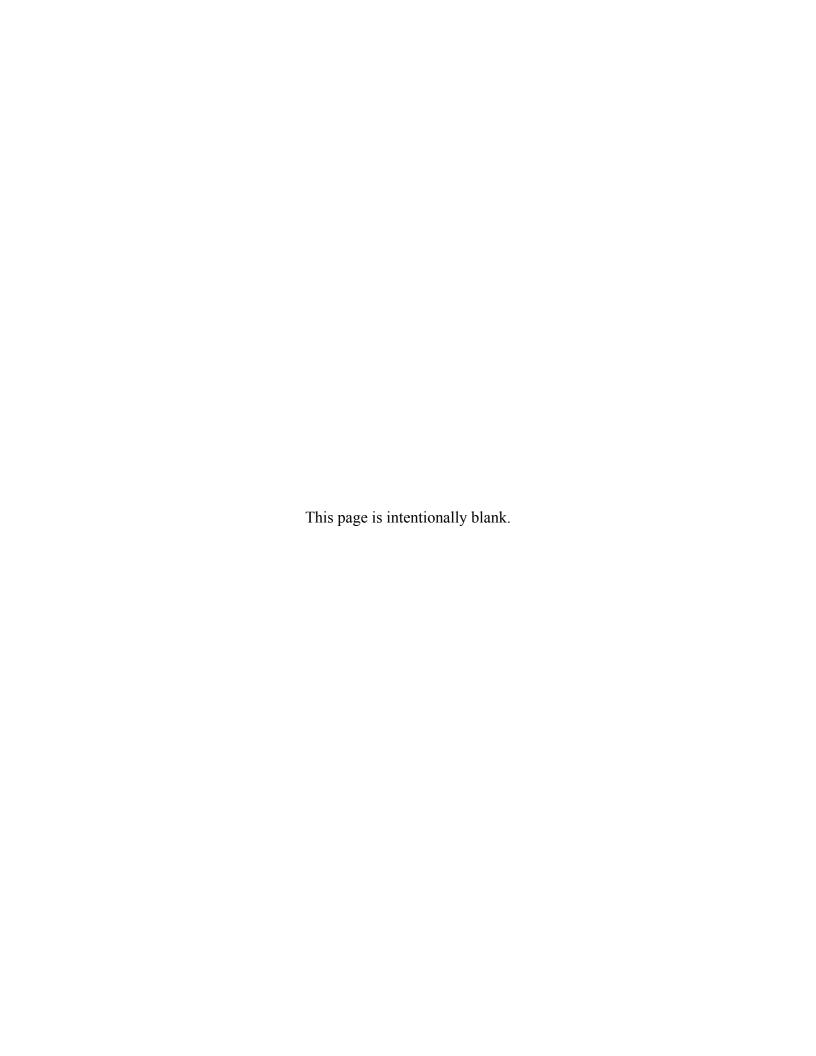

An Act to Amend Chapter 25 of the Acts of 1996, the Fisheries and Coastal Resources Act

Be it enacted by the Governor and Assembly as follows:

- 1 Section 3 of Chapter 25 of the Acts of 1996, the *Fisheries and Coastal Resources Act*, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) adding immediately after clause (d) the following clause:
 - (da) "fish products" includes fishery resources or any parts, products or by-products derived from fishery resources;

and

- (b) striking out "buying, selling, holding in possession or" in the first and second lines of clause (h).
- 2 Section 72 of Chapter 25, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) striking out "fish" in the second line;
 - (b) striking out ", packaging" in the second line; and
 - (c) adding "fisheries resources" immediately after "marketing" in the third line.
- 3 Section 73 of Chapter 25, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) striking out the comma after "buy" in the first line and substituting "or";
 - (b) striking out ", package, possess or market" in the first and second lines; and
 - (c) striking out "fish or" in the second line.
- 4 Subsection 74(1) of Chapter 25, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) striking out the comma after "buy" in the third line and substituting "or"; and
 - (b) striking out ", package, possess or market fish or" in the third line.
- 5 Section 75 of Chapter 25, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) striking out the comma after "buy" in the second line and substituting "or";

- (b) striking out ", package, possess or market fish or" in the second line; and
- (c) striking out "fish" in the fourth line and substituting "fisheries resources".
- 6 Subsection 76(1) of Chapter 25 is amended by striking out clause (a) and substituting the following clause:
 - (a) shall be granted for a period prescribed by the regulations, with a right of renewal by the licensee at the Minister's option;
- 7 (1) Clause 77(1)(a) of Chapter 25 is amended by striking out "revoke" in the first line and substituting "invoke".
- (2) Subsection 77(2) of Chapter 25, as amended by Chapter 2 of the Acts of 1999, is further amended by
 - (a) striking out clause (ca) and substituting the following clause:
 - (ca) prescribing information to be submitted to the Minister by a person processing, buying, selling or marketing fishery products who is exempt pursuant to the regulations;
 - (b) striking out ", packaging, possessing" in the third line of clause (e);
 - (c) striking out "fish or" in the third line of clause (e); and
 - (d) striking out clause (f) and substituting the following clause:
 - (f) respecting the inspection of premises or facilities used in the processing, buying, selling or marketing of fish products and vehicles used for the transportation of fish products;
- 8 Subsection 81(1) of Chapter 25 is amended by adding immediately after clause (f) the following clause:

(fa) respecting the possession and transport of live fish;
