PAGE 7, proposed subsection 8(1) - delete "to".

PAGE 7, proposed clause 11(2)(b), line 4 - add "and" immediately before "all" the first time it appears in line 4.

PAGE 14, proposed clause 44(1)(a), line 3 - add "or" immediately before "where".

PAGE 20, proposed Section 62, line 2 - delete "articles or" and substitute "memorandum of association or the articles of".

PAGE 25, proposed subsection 86(1) -

(a) add "memorandum of association or" immediately after "issuer's" in the fourth line of proposed clause (e); and

(b) strike out "89" in proposed subclause (f)(i) and substitute "88".
