PAGE 8 - add new Clause 24A after Clause 24:

- 24A (1) The Minister shall order a report reviewing this Act.
 - (2) The report must include a review of
 - (a) processing times for protection orders made under Part I and cyberbullying prevention orders made under the Safer Communities and Neighbourhoods Act;
 - (b) the time it takes investigators to investigate complaints made under the Safer Communities and Neighbourhoods Act;
 - (c) the case per investigator ratios of complaints made under the Safer Communities and Neighbourhoods Act;
 - (d) access to and adequacy of resources for educators, administrators, school nurses, cafeteria workers, custodians, bus drivers, athletic coaches, advisors to extracurricular activities and volunteers relating to cyberbullying;
 - (e) the efficacy of the Provincial school code of conduct policy in regards to the intention of this Act and the Education Act; and
 - (f) all other such measures and material considered appropriate by the Minister.
- (3) The Minister shall table the report in the House of Assembly not later than March 31st five years following the coming into force of this Act or, where the Assembly is not then sitting, file the report with the Clerk of the Assembly.

- (2) The Provincial school code of conduct policy must be updated every two years.
- (3) The regional school code of conduct policies must be updated every two years and filed with the Department of Education.

 - (a) information about what constitutes bullying and cyberbullying;

and must be posted in every school classroom, cafeteria, restroom, gymnasium, auditorium and bus and be provided to students, parents of students, teachers, volunteers and employees at each school.

- (6) The Provincial and regional school code of conduct policies must address training requirements and opportunities for teachers, school volunteers and school employees.
- (7) The principal of a school shall ensure that teachers, volunteers and employees at the school
 - (a) meet the training requirements referred to in subsection (6); and
 - (b) are afforded all reasonable opportunities for training in order to meet the requirements.
- (8) The principal of a school shall ensure that the school has an information session at least once each school-year, open to all students, parents of students, teachers, volunteers and employees at the school, respecting the Provincial and regional school code of conduct policies including, without limiting the generality of the foregoing, what constitutes bullying and cyberbullying, how to identify it, resources available and how to proceed if a child, parent, teacher, school volunteer or other individual suspects bullying or cyberbullying is occurring.
