> I was shocked to find out this morning of your government's plans to ease affordability of housing by introducing a tax on a summer non resident property owner.

- > Note, our friends just down the road from our cottage own a much more expensive cottage that can be lived in year round...but they are not subject to the tax on their vacation property because they are year round residents of Halifax.
