Dear Members of the Public Bills Committee,

Like many Nova Scotians I am very disappointed by recent actions of the present government that will serve to dismantle necessary and hard fought

democratic safeguards that have been

in place for many years. Even though the Conservative Party has a super majority of the seats the government remains ours, not theirs. In fact the increase in the majority makes it ever so important that it exercises power with responsibility not the carte Blanche way demonstrated by Bill No 1.

The present government enacted legislation for a fixed date election and then revoked this promise by telling Nova Scotians it needed a mandate to deal with Prime Minister Trudeau. Now it has repealed that legislation and the omnibus bill has little in it concerning issues with Ottawa.

Nova Scotian was a bastion of democracy in Canada but this Bill acts as cannon fodder to dismantle it. This legislation diminishes or extinguishes existing powers or rights to municipalities, universities, aboriginal peoples, landowners and civil servants. It touches on many sectors and the lives of many Nova Scotians.

Issues regarding Freedom of Information, the Auditor General, mining rights, the ability to fire civil servants without cause, power to override development and transportation decisions at the municipal level, degree granting ability at NSCC and the right to prescribe what can be taught at certain universities. All without notice. None of this was done with consultation especially with the Mi'qmaq Nation. And none of these issues were on the Conservative Party election platform so your mandate to act on this Bill is ethically questionable.

You now are using Trump instead of Trudeau to distract Nova Scotians from these outrageous power grabs. You are asking Nova Scotians to take "no" out of Nova Scotia. I'm hoping others like myself will say "no" to this Bill. Like many others I foresee the "oust" in hOUSTon.
