- -killing all the undergrowth and hardwoods with glyphosate spraying creates a huge fire risk, as does putting lumber equipment and workers in the dead and now even more bone dry undergrowth of sprayed forests to work. (Glyphosate is a desiccant!)
- between the government's recent actions of not protecting what they said they would, this horrific yearly poisoning of Nova Scotians with spraying (and with this Bill basically cutting off our abilty to even protest against it. Yet we are supposed to be a DEMOCRACY I thought??!), this no longer informing us of where and when spraying is occurring (so we can't even try to protect our water sources, not to mention ourselves and our loved ones), allowing industry to go in and continue working, yet keeping citizens out, and now trying to basically sneak and rush in these Crown Land changes (as well as so many other changes that benefit Forestry Industry ONLY) so that most Nova Scotians don't even realize what is happening, and then taking away any means we may have to protest the government's behavior.
