# **Direct benefits**

- Alice Housing is building the community one person at a time
- Outcomes show:
  - Women and children are safer
  - Women and children do not return to violent and abusive households
  - Children's coping and life skills increase
  - Women develop an action-oriented life plan
  - Women learn and implement positive parenting skills
  - Children can recover from witnessing or experiencing abuse



# **Societal benefits**

- Money invested in Alice Housing has a significant impact on the community
- Alice Housing has provided refuge to about 950 families, resulting in:
  - Reduced policing
  - Enhanced family income
  - Reduced health care costs

## **Our Gift to the Community**

#### "Healing the Bruises: Through the Eyes of a Child" launched on October 20<sup>th</sup>, 2011







- 3000 copies printed, Alice Housing absorbs majority of production costs
- 900 copies given to 300 schools province wide
- 500 copies given to every organization under DCS umbrella province wide
- Copies given to 14 libraries in HRM
- Copies given to parents, doctors, teachers, police, VON, Family Law Courts, Dalhousie Legal Aid, Dept of Justice, and many more





### **Sustainable Funding**

# The challenge

- Violence is increasing
- Demand for our services is increasing:
  - 16% increase in phone support since 2006
  - 36% increase in intakes in 2010
  - Wait list being maintained for family units
  - 11,539 bed nights in 2010-2011
- Our ability to respond has decreased loss of 7 units or 28% of our housing stock since 2005 because of sustainability issues

# We must sustain our commitment to women and children, especially at times of most need



# **Financial situation**

- \$430,000 annual operating costs
- Government funding for per diems supports < 9% of budget
- We receive no core funding from government
- Steps taken by Board of Directors to reduce costs:
  - Sold a property
  - Reduced a full-time position to part-time
  - Cut costs during budget process



# **Further Challenges**

- Current funding arrangement with DCS only \$9.75 per day only for clients on Income Assistance
- Fluctuated funding since 2005 from a high of \$51,000 to projected low of \$33,000 for 2010/2011
- Heating, electricity and water costs rising each year
- Aging buildings with rising maintenance costs
- Property taxes increase each year in spite of tax exemption
- No ability to raise rents to cover costs



# **Funding sources**



#### 2011 -2012 Breakdown of Funding Sources for Alice Housing

- Fundraising 52%
- Rental Income 25%
- United Way Grant 12%
- Government Funding (DCS) 11%



# Sustainable funding benefits

A long term sustainable funding plan is critical to continuing the work of Alice Housing



# **Government Relations**

- Representatives from Alice Housing met with Minister Peterson - Rafuse on June 7, 2011 and presented our Strategic Plan and request for ongoing dialogue.
- Request for ongoing dialogue concerning our funding needs denied on November 1, 2011



# Why now?

- To maintain current services for existing clients and increase the housing stock back to 2005 levels to meet increased demand for family units
- To provide outreach support to ensure women stay strong and are successful after leaving "With the programs, supportive counselling"

and the help other women in the program, I am now learning to live independently and believe in myself again." ~ Client



# **Funding vision**

To sustain the programs, which are valuable and cost effective, Alice Housing is pursuing government commitment to core funding to ensure the organization has long term sustainability, and can offer services to women and children in the community for years to come

We are requesting \$250,000 annually for the next three years
