Re: Standing Committee on Public Accounts – Municipal Grant Funding and Strategic Initiatives

Thank you for your correspondence dated February 13, 2024, requesting follow up information regarding rural internet coverage. Further to our appearance at the above noted committee meeting, Build Nova Scotia has compiled the attached additional information in response to the committee request.

Build Nova Scotia has service delivery agreements with Eastlink and Bell. Bell has the bulk of the remaining underserved civic addresses to complete which is approximately 10,000 across Nova Scotia.

Regarding the internet speeds, the Internet for Nova Scotia Initiative (INSI) program required proponents to meet minimum CRTC regulated speeds of 50Mbps/10Mbps. In the case of the outstanding approximately 10,000, these are all fibre to the home so it is expected that speeds will far exceed the minimum requirement. (Bell's current internet packages would range from 150Mbps/150Mbps to 1.5Gbps/940Mbps). The table requested by the Committee is attached and updates are posted on the INSI website.

As of early February 2024, approximately 94,300 homes and businesses have been connected through INSI and have access either through traditional INSI projects or the Satellite Internet Service Rebate Program. To date, we have 97.5% coverage with access to connections happening regularly, close to 99.9% when the satellite option is included.

I trust you will find the information satisfactory.

Dear Honourable Kelly Regan:

Thank you for the opportunity to meet with the members of the Standing Committee on public accounts with respect to Municipal Grant Funding and Strategic Initiatives on February 7, 2024. Following up from my offer during the meeting, please find additional information to the requested questions below:

1. How many tiny homes or Pallet homes is your department involved in providing in the province this year?

The Department of Community Services has committed to providing 200 pallet shelters. The pallet shelters are designed as single units, meaning that 200 individuals experiencing homelessness will access these units. The Department of Community Services, working with the Department of Municipal Affairs and Housing, has also committed to providing 60 'Tiny Homes' – 50 singles and 10 doubles (accessible) – for 70 individuals transitioning to supportive housing.

2. In terms of the incentives with private developers for access to a forgivable loan for building affordable units, how many affordable units, by your definition, have been created through that program to date in Nova Scotia and how many have been committed to?

So far through the program, 1,185 affordable units have been created. In addition, a further 727 have been committed to since the inception of the program.

3. Provide a list of which municipalities will be receiving less in Municipal Financial Capacity Grant funding under the new formula and how much less they'll be receiving.

Instead of providing a list of the municipalities receiving less Municipal Financial Capacity Grant funding, the Department has decided to offer a more comprehensive chart that includes Municipal Financial Capacity Grant funding for all municipalities. Appendix A includes current funding levels, the updated funding amounts through the new modernized Municipal Financial Capacity Grant formula, and 5-year transitional support leveraged to municipalities.

4. Provide the list of the 500 active projects that are currently happening in communities across Nova Scotia.

Appendix B includes a list of active projects that are specific to the Municipal Infrastructure Division; Appendix B is not an exhaustive list of all projects. The approximate "500 project" count that was mentioned during the meeting was qualified to say that a significant portion of projects (nearly half) are under the Canada Community-Building Fund, and as such, are planned projects that we cannot share publicly. In addition, some active projects from other programs have been omitted as they have not yet been formally announced.

5. The 911 fee that's collected on behalf of municipalities by the Province, how is that managed? Is the total filtered back to municipalities? If not, where does the rest go?

The 911 fee is collected by the Province to defray the cost of the Provincial 911 Program in Nova Scotia. In return, the Province performs the following functions:

- Administers the 911 service (established in 1997 under the Emergency 911 Act and Regulations).
- Provides a means for the reporting of emergencies and effective transfer to appropriate first response organizations.
- The Province processes all 911 calls and has established four Public Safety Answering Points (PSAPs) with the Royal Canadian Mounted Police, Cape Breton Regional Municipality, Halifax Regional Municipality, and Valley Communications, as well as two Secondary PSAPs with the Emergency Health Services Communication Centre and Shubie Radio.
- Provides Provincial oversight with MOUs and 911 Policies and Standard Operating Procedures (SOPs) with the four Primary PSAPs.
- Approximately 360,000 911 calls were processed in 2022/23.
- Collects 43 cents per phone line.
- Provides 911 Civic Address Grants of \$327,000 annually to all Municipalities to maintain civic addresses for their respective areas within Nova Scotia. This information is uploaded to a centralized database and utilized for the 911 Mapping function.
- In addition, the 911 fee that is collected covers the following costs:
 - Costs for all necessary 911 equipment and telecommunication circuits within 911
 Training Lab, four Primary, two Secondary PSAP's and their back-up sites.
 - Costs for all new 911 Call Takers Training and Certification at the Nova Scotia Emergency Management Office's 911 Training Facility; and,
 - Costs of the Emergency Management Office 911 Division Operational Budget.
