(d) the Community Services Committee is established for the purpose of considering matters normally assigned to or within the purview of the Departments and Ministers of Business and Consumer Services and of Municipal Affairs and matters relating to the Human Rights Commission and the Nova Scotia Sport and Recreation Commission<sup>1</sup>

In 1998, the Speaker, as Chairman of the Legislature's Internal Economy Board, gave the Community Services Committee written permission to also consider matters within the purview of the Department of Health and the Department of Community Services.<sup>2</sup>

## **BACKGROUND INFORMATION**

The Youth in Care Newsletter project was developed by the Children's Aid Society of Halifax in conjunction with Andrew Safer in order to keep youth at risk engaged within the system and to try to help the youth express their feelings concerning the foster care system in Nova Scotia. The youth are able to focus on issues that are of interest to them while learning skills that will be helpful in the future. The expression of emotion through the interviewing and writing process is an important step in helping the youth at risk express themselves and teach those around them about what is happening within the system from someone who is intimately involved and affected by foster care.

Participants in this project range in age from 14–19 years old. The youth involved in this project all live in some type of care facility such as foster care, group homes or assisted independent living. This project currently takes place in both the Halifax Regional Municipality and Cumberland County

The Youth In Care Newsletter Project is sponsored jointly by the Youth Employment Project (a jointly funded Federal and Provincial Program) and the Children's Aid Society Foundation of Halifax.

The Halifax youth are currently starting to put together their fourth newsletter and the Amherst program is at the beginning of their second newsletter.

## **BACKGROUND INFORMATION**

Nova Scotia started building a Secure Care Centre in Truro, Nova Scotia in 2001. When the senior officials from the centre appeared before the Committee, the centre had just opened its doors to children for the very first time.

This centre and the programs within its walls were developed in order to help stabilize children who have behavioral and emotional problems, provide crisis intervention, work towards a treatment plan and transition to longer-term treatment program or facility. The Secure Care Centre can accommodate up to 20 children at any one time. The centre is only meant to be a temporary measure, not a long-term living arrangement. Nova Scotia's Children and Family Services Act only allows children to be placed in this facility for a maximum of 90 days.

## **MATTERS OF DISCUSSION**

Children and Family Services Act, details concerning use of the Act, authority of Minister, licensing, meeting the facilities criteria for admittance;

Chronology of the secure treatment program, recidivism of the children;

Case loads within the facility, details concerning the facility, treatments available, on-site therapy, development of programs; support systems within the community organizations, Children's Aid, foster care system, families groups; and

## **BACKGROUND INFORMATION**

### **Federation of Foster Families of Nova Scotia**

The Federation of Foster Families of Nova Scotia is the collective voice for all foster parents in Nova Scotia. The Federation was created in 1974 and federally incorporated in 1976. The Federation is a charitable organization funded by the Department of Community Services and governed by a board of directors made up of foster parents from across the province.

Foster care provides substitute families to children and youth who are unable to be in their birth family for different reasons and varying length of time. The aim of this program is to provide safe, loving and nurturing foster homes for children and youth. Children and youth need foster care because of a family crisis, physical, sexual or emotional abuse or neglect, substance abuse or parental or adolescent conflict. As a result of these experiences, most children have needs that require time and attention. The Federation offers a number of services such as individual support with a social worker, a group support system, foster parent training and financial support in order to help facilitate this arrangement.

### **Halifax Children's Aid Society**

The Province of Nova Scotia has an act entitled the Children and Family Services Act, which provides the mandate for agencies such as the Children's Aid Society. There are 14 Children's Aid Societies in Nova Scotia. These agencies provide 24-hour service and they are mandated to provide emergency services across the province related to children. In Nova Scotia any person under the age of 16 is considered a child. The Children's Aid Society works closely with family support agencies, psychologists, substance abuse counselors and other helping professionals to try to bring services to families. The Children's Aid Society does not only work with the Federation of Foster Families of Nova Scotia, but they also place children with adoptive parents.

## **MATTERS OF DISCUSSION**

The Committee went into details on the following matters:

Private Agencies - 14 Private, 6 regional office under provincial jurisdiction, allegations of misconduct, investigation of a number of homes that have therapeutic programs for the disabled;

Maintenance Rates - Statistics Canada information (\$42.70 / day) estimated rates on what they should be in Nova Scotia. Financial statistics from the Federation ( 0-9 \$13.77 / 10 and up \$20.02) of per child rates and school supplies and clothing allowances;

Foster Parents - operating budget, mandatory programs / training for foster parents must take to qualify for children, crisis situation due to lack of parents in the system;

Children's Aid - Children and Family Services Act - mandatory cut off at 16 years old, children between 16-19 falling between the cracks, placements, use of hotels if space is not available, splitting up siblings, recruitment efforts; and

SOS Children's Village - loss of placement spaces.

## **BACKGROUND INFORMATION**

Over thirty years ago a group of concerned citizens, who were researching housing needs in Nova Scotia recognized the extent of violence and abuse suffered by women and children in their own homes. The group discovered that there was a lack of support and resources and as a direct result a group of activists in Nova Scotia commenced work on establishing the first transition house in Nova Scotia. Bryony House opened its doors in 1978. Nova Scotia currently has 11 transition houses located throughout the province.

The Transition House Association of Nova Scotia (THANS) is the unified provincial voice for organizations, which provide direct services to abused women and their children in Nova Scotia.

## **MATTERS OF DISCUSSION**

The Committee went into details on the following matters:

Process surrounding the government's budget cuts to THANS (\$897,000) in April 2002 and the temporary reinstatement and freezing of budgetary funds;

The January 2004 Department of Community Services response to THANS Report of May 2003, the government would like to break the Province up into regions but THANS sees transition houses as one organization not to be marginalized. The Department also mentions in their response that they would like to try a few pilot projects but THANS is not aware of what these projects would entail. The Department of Community Services would like to hold regional meetings but THANS refuses to deal with them on anything but a provincial level;

THANS would like to look into the possibility of inter-departmental funding for their various projects. THANS feels that this is a viable option;

Due to government reclassifications all staff paid for by provincial funds received a 9.3% raise, this left THANS in a difficult situation since only some of their employees were covered by the raise. Members of THANS decided to give all employees raises. This was accomplished through fund raising efforts;

Use of facilities and where do the women and children go when turned away by THANS due to lack of capacity. Occupancy rates and issues were discussed in-depth. Outreach programs were also discussed especially where there is a need for outreach services in rural Nova Scotia;

The working relationship that THANS has with the various regional police forces and the Royal Canadian Mounted Police was discussed. The police now have a zero tolerance policy when it comes to dealing with family violence. This policy has increased the users of THANS facilities throughout the province;

THANS discussed the statistics concerning the length of time women stay with the family in abusive relationships; and

The Committee asked THANS officials about emergency protection orders, temporary restraining orders, peace bonds and wheelchair accessibility of the facilities.

## **MOTION**

The Committee passed the following motion unanimously addressed to the Minister of Community Services:

The Standing Committee on Community Services urges the government to provide stable long term funding for transition houses in Nova Scotia

## **BACKGROUND INFORMATION**

The Department of Community Services is working closely with the Federal, and Municipal governments as well as community organizations to have a coordinated approach to the affordable housing needs in Nova Scotia.

Nova Scotia signed the Canada-Nova Scotia Affordable Housing Agreement in September 2002. Under the agreement the federal government is investing \$18.6 million with an equal amount to be matched by the Nova Scotia government and their partners for a total of \$37.26 million. This investment will enable up to 1500 housing units to either be built or renovated over a five-year period. The number of units will depend on the amount of assistance provided to each unit and the number of proposals received by the program.

Since that signing the province has engaged in extensive consultations with the stakeholders in housing in Nova Scotia to determine what the details and structure of the program should be. This process is to help identify the housing needs throughout the entire province.

## **MATTERS OF DISCUSSION**

The Committee went into details on the following matters:

CMHC Agreement;

Affordable Housing Program - 18.63 Million for both Federal and Provincial governments, estimates concerning new housing versus renovations, HIL Formula, home ownership criteria, audit and performance;

40,000-60,000 clients per year use housing programs, public housing model, percentage of income required for housing, 2001 census numbers, Kyoto Accord, tenancies boards; homelessness problem in Nova Scotia

Sackville Housing Project, HRM negotiations, sewer and water extensions;

Seniors wait list for housing, calculation of said wait list;

Non-profit housing societies, wheel chair access; and

Needs of the African Nova Scotia communities with specific mention of the Preston Area. 11.

The Department of Community Services believes that the best place for children to be is with their families but failing this due risk of abuse or neglect to the child, the child welfare system is in place to protect the child and support the family, with the hopes of enabling the family unit to remain intact.

Rural versus urban housing concerns, homelessness;

Loss of rural infrastructure especially transportation;

Newest centre - Tri-County Services received interim HRDC funding for two years until it proved itself and then provincial funding kicked in;

Adding satellite centres in communities currently not served by a women's centre (Amherst, Truro etc.); and

Needs of adolescents - dealing with peer pressure, depression, sexual assault and harassment, hostile home environments etc. Program for at-risk girls.

The Committee passed the following motion unanimously addressed to the Minister of Community Services:

That the Government of Nova Scotia recognize Womens' Centres as a vital service by providing stable, adequate funding and sufficient staffing levels to all centres in their communities across the province.

### **BACKGROUND INFORMATION**

The Standing Committee on Community Services has heard from the Department of Community Services a number of times concerning the new Secure Care Centre. Ms. X has been aware of these meetings and has kept abreast of what has been said.

During the Thursday, December 11, 2003 meeting concerning the Secure Care Centre, Ms. X indicated that in her opinion there were a number of misconceptions concerning the facility.

Ms. X wrote the Committee and asked to appear as a witness in order for her to relate her experiences to the Committee in her capacity as the mother of the first child to enter the Secure Care Centre.

### **MATTERS OF DISCUSSION**

The Committee went into details on the following matters:

Ms. X told the committee of her experiences dealing with an emotionally disturbed child and the expectations she had for the newly opened Secure Care Centre. The committee members were told that they learned this is not a treatment centre but a Secure Care Centre, from which Ms. X's son has already escaped the centre twice.

When this centre opened it was hoped that more than 25 children that who being treated outside of Nova Scotia could be integrated into the new facility over time so they could be treated in Nova Scotia. Since there are no doctors on site at the centre this is not possible at this time.

Ms. X told the committee about the IWK Adolescent centre for Treatment Program, which has very successfully treated her child. However, this program is voluntary and her child can check himself out at anytime as long as a doctor agrees.

Ms. X's child has been in Reigh Allen Crisis Centre a number of times however, this is not a secure treatment facility.

Currently, Ms. X has an application in for her child to be sent out of province (near Ottawa) in order to receive treatment.

Ms. X went into detail concerning the gaps that she feels are currently present in the system.
