INTRODUCTION

The Standing Committee on Community Services, an all-party Committee of the House of Assembly, was struck at the beginning of the First Session of the Sixty-Second General Assembly. Pursuant to Rule 60(2)(d) of the *Province of Nova Scotia Rules and Forms of Procedures of the House of Assembly:*

(d) the Community Services Committee is established for the purpose of considering matters normally assigned to or within the purview of the Departments and Ministers of Business and Consumer Services and of Municipal Affairs and matters relating to the Human Rights Commission and the Nova Scotia Sport and Recreation Commission.

In 1998, the Speaker, as Chairman of the Legislature's Internal Economy Board, gave the Community Services Committee written permission to also consider matters within the purview of the Department of Health and the Department of Community Services.

Housing Nova Scotia (HNS) appeared before the committee to provide an overview of their programs and services as well as information on affordable housing projects in the province. HNS is a provincial government corporation that is responsible for assisting low-to modest- income Nova Scotians with their housing needs and ensuring a range of programs, services and homes are available to Nova Scotians. HNS was created in August 2013 as a result of the provincial Housing Strategy. The operations and priorities of HNS have been reviewed to assist in the creation of a strategic plan, which will be released this year. The 2014/15 budget for HNS was \$194.3 million. It is responsible for \$330 million in fixed assets and \$675 million in financial assets. Five housing authorities located across the province are responsible for managing 11,500 public housing units.

This program is being offered in 12 schools on the South Shore.
