## Preamble

People across the province are concerned about their ability to access emergency care. This is a years long crisis that has seen renewed urgency since the tragic deaths of Allison Holtoff and Charlene Snow.

The NSGEU represents staff at the Halifax Infirmary, many of whom are at their wits' end.

They came together and assembled a list of 59 straightforward suggestions to improve emergency care at the Halifax Infirmary. Some of the suggestions are as simple as replacing the payphone in the waiting room with a free phone that people can use to call family when they're waiting for eight plus hours, or make sure that there is food available at all hours. Others would make a big difference in the recruitment crisis like covering nurse's parking expenses and providing retention bonuses.

Unfortunately, the government has yet to respond to the letter.

- I move that the committee write to the Department of Health and Wellness in support of the staff at the Halifax Infirmary, and ask that the department please provide a written response as soon as possible.

## <u>Preamble</u>

People across the province are concerned about their ability to access emergency care. This is a years long crisis that has seen renewed urgency since the tragic deaths of Allison Holtoff and Charlene Snow.

The NSGEU represents staff at the Halifax Infirmary, many of whom are at their wits' end.

They came together and assembled a list of 59 straightforward suggestions to improve emergency care at the Halifax Infirmary. Some of the suggestions are as simple as replacing the payphone in the waiting room with a free phone that people can use to call family when they're waiting for eight plus hours, or make sure that there is food available at all hours. Others would

make a big difference in the recruitment crisis like covering nurse's parking expenses and providing retention bonuses.

Unfortunately, the government has yet to respond to the letter.

# July 11, 2023
