FOREWORD & MANDATE

FOREWORD

The report of the Standing Committee on Human Resources is written in accordance with the *Province of Nova Scotia Rules and Forms of Procedure of the House of Assembly.* First, outlining the role of the committee with respect to approving or not approving applications to provincial Agencies, Boards and Commissions. Second, providing a brief summary of witnesses and topics that came before the committee as assigned under the committee's mandate.

MANDATE

Functions of Standing Committees

60(2)(c) the Human Resources Committee is established for the purpose of

- (i) considering matters normally assigned to or within the purview of the Departments and Ministers of Education and Culture and of Labour,
- (ii) reviewing and approving or not approving candidates for appointments to agencies, boards or commissions where the Governor in council has, pursuant to an enactment, the sole discretion to make the appointment or where the Governor in Council makes the appointment by choosing from a list of nominees provided to the Governor in Council pursuant to enactment,
- (iii) reviewing and approving or not approving ministerial appointees to agencies, boards or commissions where, pursuant to an enactment, Governor in Council approval is not required, and
- for purposes of greater clarity and certainty, the committee shall be guided by the terms of reference set out herein and which form part of this Rule;

TERMS OF REFERENCE

Terms of Reference in Reviewing Agency, Board and Commission Appointments:

1. Where Governor in Council approval is required for an appointment to an Agency, Board or Commission, after consideration by Executive Council of a person recommended for appointment to an Agency, Board or Commission, the Clerk of the Executive Council shall submit the name of the person to the Human Resources Committee, on Form "A".

- 2. Prior to making a Ministerial appointment to an Agency, Board or Commission for which Governor in Council approval is not required, a Minister shall submit the name of the name proposed appointee to the Executive Council for consideration. Where the Executive Council recommends the name, the Clerk of the Executive Council shall submit the names of the person to the Human Resources Committee.
- 3. Committee members shall review the name submitted for approval having regard to qualifications of the individual, affirmative action concerns and, where relevant, the regional representativeness of the Agency, Board or Commission.
- 4. The purpose of the committee review is not to replace the function of Government Departments and Ministers in making appointments. Its function is to approve or not approve the name before it, not to consider or recommend alternative names for appointments.
- 5. The following appointments shall not be submitted to the Human Resources Committee for review:
 - (a) appointments of provincial public or civil servants by virtue of their employment
 (i.e. the Deputy Minister of Finance is an unpaid member of the Lotteries Commission);
 - (b) candidates selected by an open competition and selection process or peer review
 (i.e. Provincial Judges selected by the Judicial Appointments Committee or employees of Agencies, Boards or Commissions);
 - (c) candidates recommended for appointment to self-regulatory bodies who are elected or recommended by the body (i.e. Nova Scotia Medical Society);
 - (d) candidates recommended for appointment to Hospitals and Universities where the candidate is recommended by the Board of Governors or Director of the institution.
- 6. The committee may interview a recommended candidate where a majority of members support a motion to interview a particular recommended candidate.
- 7. The committee shall not hear submissions or representations from anyone not a member of the committee.
- 8. Meetings of the committee shall be open to the public unless the committee by majority vote determines to meet *in camera*.
- 9. The committee shall meet at least once a month every month of the year irrespective of whether the House of Assembly has been prorogued.
- 10. The committee shall approve or not approve recommended candidates on the basis of a simple majority.

- 11. The committee shall make recommendations with respect to every name submitted by Executive Council on the day it appears on the agenda unless a majority of members agree to defer a recommendation to the next meeting.
- 12. Recommendations of the committee shall be accepted by the Executive Council and the Minister responsible for the appointment.
- 13. The agenda for meetings and a list of recommended candidate and Form "A" will be provided to all members one week in advance.

INTRODUCTION

The Standing Committee on Human Resources, an all-party committee of the House of Assembly, was struck at the beginning of the First Session of the Sixty-Third General Assembly, pursuant to Rule 60(2)(c) of the *Province of Nova Scotia Rules and Forms of Procedure of the House of Assembly*.

PROCEDURES AND OPERATIONS

The Human Resources Committee meets on the last Tuesday of every month in the Legislative Committees Office.

AGENCIES, BOARDS AND COMMISSIONS PROCESS

During the First Session of the Fifty-Sixth General Assembly (1993), an amendment was made to Rule 60 of the *Province of Nova Scotia Rules and Forms of Procedure of the House of Assembly*. This amendment increased the mandate of the Standing Committee on Human Resources. The committee has been assigned responsibility to review potential appointments to nearly all government Agencies, Boards and Commissions (ABCs).

Appointment Process

There are two ways in which an appointment can be made to an Agency, Board or Commission. They are as follows:

- Order in Council
 Order in Council appointments require both the Executive Council (Cabinet) and the Lieutenant Governor's approval.
- ii. Ministerial Ministerial appointments are made by the Minister responsible for the Agency, Board or Commission. The appointments are forwarded to the Executive Council (Cabinet) for review.

Since 1993, the Human Resources Committee has been assigned responsibility to review both forms of appointments. The only appointments that the committee will not consider are those excluded by Rule 60(2)(c)(iv)5(a-d) of the mandate contained within the *Province of Nova Scotia Rules and Forms of Procedure of the House of Assembly.*

Agencies, Boards and Commissions come in different forms, ranging from advisory bodies to arms-length Crown corporations, and have different roles, mandates, authorities and jurisdictions.

Number of Agencies, Boards and Commissions

Currently there are 154 active Agencies, Boards and Commissions. There are approximately 757 people currently appointed to ABCs.

Remuneration

The remuneration for Agencies, Boards and Commissions' members varies among different boards. For example, the Public Accountants Board pays \$500 per meeting plus travelling expenses; the Shubenacadie Canal Commission compensates for expenses only.

Bulk Advertisement

Once every six months a list of upcoming vacancies for all government Agencies, Boards and Commissions is generated. These vacancies are advertised through Communications Nova Scotia according to the Standing Committee on Human Resources' advertising policy (July 23, 1998). In addition, the departments can place ads for individual ABCs when required, and vacancies are posted on the Executive Council Office's website as they occur. Applicants can apply at any time.

DEPARTMENTAL SCREENING PANELS

Once the individual applications are forwarded to the department, the screening panels are consulted. All appointments, even those being reappointed to a board, must go through the screening panel process. Screening panels are appointed by the individual Ministers to screen all applicants to ABCs to ensure that all candidates are chosen in a fair and equitable manner.

The screening panels are to be made up of volunteers from the community. The members of the screening panels need to have technical expertise, they should represent the stakeholders of those particular ABCs which they oversee and there should be some regional representation within, where appropriate.

The mandate of the Screening Panels, as established by the Executive Council, is as follows:

Screening Panels

Screening panels were established as a matter of discretion. The purpose of screening panels was to establish a mechanism to determine qualified candidates for appointment to ABCs to assist Ministers in the selection of candidates to fill vacancies on ABCs.

Screening panel members are selected by Ministers on the basis of experience in the area of concern to the department, having regard for expertise, regional representation, gender, racial and other affirmative action considerations. Departmental staff assist the Minister in recruiting screening panel members.

Once the screening panel has approved a candidate, his/her application is entered into a pool of candidates from which the Minster may select applicants for appointment. The signed paperwork is then forwarded to the Clerk of the Executive Council. The applications are sent to Cabinet prior to being sent to the Standing Committee on Human Resources.

Once Cabinet approval is obtained, those applications that the Human Resources Committee is mandated to approve or not approve are sent to the Legislative Committees Office and placed on the Standing Committee on Human Resources' agenda.

The material is received no later than the Friday, eleven calendar days prior to the scheduled Human Resources Committee meeting. The material is distributed to all committee members on the Tuesday, one week in advance of the meeting, as dictated by the *Province of Nova Scotia Rules and Forms of Procedure of the House of Assembly*.

If the appointments are approved, the material is returned to the Executive Council Office. If the appointments are not approved, the material is also returned to the Executive Council Office, whereupon it will be returned to the appropriate department with a letter explaining the circumstances surrounding the rejection.

MATTERS OF DISCUSSION

The Executive Council Office is responsible for administering the process of appointments to non-adjudicative Agencies, Boards and Commissions (ABCs). As this was the first meeting of the newly constituted Committee, Ms. Janice Brown gave members an overview of the process, particularly of the committee's role in approving appointments.

Mr. Gordon Hebb gave members a brief introduction to the Legislative Counsel Office, which provides legal and procedural advice to the House of Assembly and to the chairs, members and staff of its committees. He spoke particularly about the confidentiality of the personal information members receive about appointees in their ABC packages.

COMMITTEE BUSINESS

The committee reviewed appointments to Agencies, Boards and Commissions. All appointments were approved.

The committee discussed its regular meeting days and times. A motion was introduced:

- [That the committee meet] the last Tuesday of the month at 10:00 am.
 - o Moved by Mr. Chuck Porter, MLA
 - Motion carried.

The Chair noted the last Tuesday of December 2017 would fall on the Boxing Day holiday, and called for an alternative day that month, since the committee is required to meet monthly. A motion was introduced:

- [That the Chair] look at some time when we're not conflicting with another committee, perhaps the week before or the day before, to make an arrangement for that.
 - o Moved by Mr. Chuck Porter, MLA
 - Motion carried.

The committee discussed whether to hear from witnesses at meetings held during those months while the House of Assembly is sitting. A recommendation was made:

- To simply move through appointments of ABCs rather than including witnesses as part of scheduled agendas [when the House is sitting].
 - o Recommended by Mr. Ben Jessome, MLA Chair
 - o Recommendation accepted.

The Chair announced the October 31 meeting would be for agenda-setting, and asked all caucuses to submit their list of proposed witnesses to the Clerk by October 17, for discussion at the meeting. He noted common practice has been that submission for witnesses reflects the representation in the House: Specifically, three from the Liberal Caucus, two from the Official Opposition, and one from the New Democratic Party. A motion was made:

- [That the committee] continue to carry on that practice.
 - o Moved by Ms. Lohnes-Croft, MLA
 - Motion carried.

AGENDA SETTING October 31, 2017

MATTERS OF DISCUSSION

The purpose of this meeting was to consider appointments to Agencies, Boards and Commissions, and to set the committee's agenda of witnesses for the coming year.

COMMITTEE BUSINESS

The committee reviewed appointments to Agencies, Boards and Commissions. The list included a late submission from the Department of Labour and Advanced Education for appointments to the Minimum Wage Review Committee.  - o Moved by the Hon. Pat Dunn, MLA

After some discussion, the committee voted to amend the original motion, to include the second topic only. A motion was introduced on the amendment:

• The amendment would be to accept [the second topic], which is Mount Saint Vincent to come in for early childhood education. The second part of that amendment would

be for us to take back the other request, and perhaps bring it forward at a future date for more discussion.

Once the committee agreed to amend the motion, the Hon. Pat Dunn's original motion was re-introduced, as amended:

MATTERS OF DISCUSSION

The Department of Labour and Advanced Education is responsible for skills training and development in all occupations and professions in Nova Scotia. Deputy Minister Montgomerie introduced Ms. Marjorie Davison as the first CEO of the Nova Scotia Apprenticeship Agency, a division of the department established in 2014 specifically to oversee training in the province's 69 designated trades. Programs designed to promote education and employment in trades are aimed at a variety of Nova Scotians including young people, immigrants and people changing careers for reasons such as layoffs. The Deputy stressed the importance of the department's partnerships with stakeholders such as the private sector, post-secondary education institutions and unions. Another key factor is labour market awareness, i.e. predicting future trends. Atlantic Canada has recently harmonized 80 per cent of its trades, and the Nova Scotia Apprenticeship Agency is working to improve mobility within Nova Scotia, and even across provincial borders. The Deputy noted that for the first time in 30 years, Nova Scotia has seen in-migration of young people for two years in a row – that is, more young people are arriving than leaving.

COMMITTEE BUSINESS

The committee reviewed appointments to Agencies, Boards and Commissions. All appointments were approved.

Members discussed a witness and topic the Progressive Conservative members had proposed during the October 31 agenda-setting meeting: The Nova Scotia Child Care Association, on Pre-Primary and Impacts on the Child Care Sector. At the time, members had voted to defer this topic. A motion was introduced:

- That we would support that topic and we would like to bring in with them the
 Department of Education and Early Childhood Development at the same time, now
 that the consultation is done, to have a full discussion on that and hear from all sides
 of the sector.
 - Moved by: Mr. Chuck Porter, MLA
 - Motion carried.

The Chair announced that Public Service Commissioner Ms. Laura Lee Langley, the approved witness for the December 12 meeting topic, would not be available on that date. The committee agreed to Ms. Langley's request that Mr. Steven Feindel, the PSC's Executive Director of Client Service Delivery, be allowed to speak in her place.

The committee agreed by consensus to the Chair's request that Mr. Chuck Porter, MLA, chair the December 12 meeting, since Mr. Jessome wished to sit among the other members and question the witness, and the Vice-Chair would be out of the country on Speaker's business.

YOUTH RETENTION IN THE PUBLIC SERVICE

December 12, 2017

MATTERS OF DISCUSSION

The Public Service Commission (PSC) is part of an interdepartmental committee, led by the Department of Labour and Advanced Education, on youth employment in general. The provincial government is one of the largest employers in Nova Scotia, and the PSC's efforts in this area have focused on:

- Hiring and retaining younger workers in full-time permanent jobs with the province;
- Helping younger workers gain experience through part-time and temporary jobs including summer programs, co-ops and internships.

Over the past two years, Nova Scotia has seen more young people move into the province than leave it. This is reflected in a shift toward more younger workers in the provincial government. As of December 2017, about 18 per cent of government's total workforce was age 35 or under. Between April and December of that year, 616 people hired in the public service were 35 or younger. That represents about 47 per cent of hires during that period. As of December, 63 per cent of them still worked in government, 13 per cent on a full-time basis. The rest had casual, seasonal and relief positions. These numbers surpassed the PSC's initial targets.

COMMITTEE BUSINESS

- 1. As agreed upon in the November 28 meeting, Mr. Chuck Porter, MLA chaired this meeting.
- 2. The committee reviewed appointments to Agencies, Boards and Commissions. All appointments were approved.
- 3. Members discussed the agenda-setting motion that was passed on November 28. The committee had agreed to accept the PC topic Pre-Primary and Impacts on the Child Care Sector, as long as representatives from the Department of Education and Early Childhood Development were included as witnesses, as well as the proposed witnesses from the Nova Scotia Child Care Association. A motion was introduced:
 - That Janet Lynn Huntington, executive director of the Early Years branch and Vicki Elliott-Lopez, executive director of Child Care and Licensing, from the department, be included in that meeting.

- o Moved by Mr. Ben Jessome, MLA
- Motion carried

COMMITTEE BUSINESS

Because of bad weather, the January 30 meeting was postponed to the next day, and the planned witness was rescheduled to appear on a later date.

The committee met January 31, only to review appointments to Agencies, Boards and Commissions. All appointments were approved.

PRE-PRIMARY AND IMPACTS ON THE CHILD CARE SECTOR

April 24, 2018

MATTERS OF DISCUSSION

Ms. Pam Streeter represented owners of private child care centres. She provided data to support her assertion that the province's Pre-Primary program is drawing the best-qualified staff away from the private child care sector. The province can pay early childhood educators (ECEs) more than the private sector can afford to, and although the province is giving funds to private child care centres to help them boost their salaries, more is needed. Moreover, caring for preschool students is more cost-effective than for infants and toddlers, who require a higher ratio of staff to children. When they lose their four-year-olds, private child care centres essentially lose their biggest source of income. Filling the empty spaces with more infants and toddlers may seem like a solution, but it won't make up the financial shortfall.

Ms. Lisa Davies spoke on behalf of operators of non-profit child care centres. They face issues similar to the those of private centres, especially losing qualified workers to the school programs. They were also concerned about losing their four-year-olds: "Preschool spaces are the moneymakers of a multi-age centre." She said non-profit centres might have to raise fees for infants and toddlers, in spite of government grants, which would be hard on the communities they serve.

Ms. Davies and Ms. Streeter both said they appreciated the province's efforts toward a smooth integration, and they would continue to work with the Department of Education and Early Childhood Development on this goal. But they noted concerns about how quickly the program was introduced and implemented.

Deputy Minister Cathy Montreuil gave some background on the Pre-Primary program, with participation figures from the current academic year (2017-18) and the coming year (2018-19). She spoke about providing the service to people who can't afford child care, and in all parts of Nova Scotia, including rural areas where daycare centres are not always available. She also discussed other early childhood services the province provides through various government departments for children even younger than four, such as 18-month well baby visits, family resource supports and immunization clinics. She acknowledged Pre-Primary's impact on existing

child care centres, and said her department would continue to work with operators to ease the transition.

NOVA SCOTIA EMPLOYMENT TRENDS 2008 - 2017

May 29, 2018

MATTERS OF DISCUSSION

The witnesses provided figures on Canada's and Nova Scotia's labour markets from 2000 to the present. They chose to broaden the approved topic's range of dates, to put the global financial crisis of 2008-09 in context. The presentation examined the relationship between demographics, labour markets, productivity and economic growth.

The Canadian workforce has undergone profound changes over the past 20 years as the dominant Baby Boomers (born between 1946 and 1965) have begun to retire. Our economy is rapidly losing older, experienced workers, and there are smaller numbers of inexperienced workers to fill the gaps. This is especially notable in Atlantic Canada, which has seen several decades of young people leaving the region to find jobs elsewhere. This trend of out-migration has reversed, as of this year, but the effects are still there.

Despite the shrinking labour force, Nova Scotia's gross domestic product (GDP) has grown during this period -- particularly over the past four years, after a dip in 2012-13. The smaller workforce poses a challenge to the province's economy, but it is a manageable one over the long term because there are other factors to offset it:

- Our economy relies more heavily on knowledge now, and less on the production of goods.
- Even within goods industries, companies are changing their business practices for example, investing in technology, which means they can maintain or grow production with fewer workers, provided those workers are skilled.
- With its many universities and community colleges, Nova Scotia has a particularly skilled younger workforce.

EARLY CHILDHOOD EDUCATION REGARDING PRE-PRIMARY AND ANY INCREASE IN APPLICATIONS/STUDENTS

June 26, 2018

MATTERS OF DISCUSSION

Dr. Nunes presented a profile of Mount Saint Vincent University and its Department of Child and Youth Study. The Department has about 310 students a year in total (not all in early childhood education), with about 98 new students per year. Those numbers show a 46 per cent increase over the past decade, but they have been stable for the past five years.

The province's new Pre-Primary program will require more qualified Early Childhood Educators (ECEs) in Nova Scotia, but so far that has not resulted in more students at the MSVU program. Dr. Nunes noted students often complete the early stages of their qualification elsewhere, such as the Nova Scotia Community College's diploma program (Level 2 ECE), and then transfer those credits to MSVU to use toward their degree program (Bachelor of Arts in Child and Youth Study), which would give them higher qualifications (Level 3 ECE). The department expects numbers in its bachelor's program to increase in the future, and it is ready to accommodate them.

At present there are 2,700 qualified ECEs in Nova Scotia, and 1,700 are working in the field. The rest have gone to other locations, other degree programs, other jobs in related sectors, or other fields completely. The province has said it will need to hire 700 new ECEs by 2020. There are qualified people out there, but to recruit and retain them, the province will have to address three factors: low wages, stressful working conditions, and a general lack of recognition of ECEs as highly trained professionals. These factors are common across Canada.
