BACKGROUND INFORMATION

Northern Lumber Ltd. was established in 1996 in Brule Point, Nova Scotia by a small group of businessmen in the Tatamagouche area. The Company was built with the capacity to process approximately 1 million board feet of hardwood lumber per year. Northern Lumber dried the green lumber and manufactured it into edge glued laminated panels which could be used in the manufacturing of furniture, kitchen cupboards, stair treads etc. Northern Lumber employed fifteen people year round with an annual payroll of three hundred thousand dollars.

The lumber used by the company was bought from several different mills from Nova Scotia. When a new modern hardwood mill opened in Fox Brook, Pictou County (owned by Savoie Dickson) it was understood that the small value-added manufacturing companies, like Northern Lumber Ltd. would be able to purchase the lumber at market price. However, when the mill opened, the majority of the lumber was directed to mills and the lumber produced was shipped to Savoie Dickson owned value added plants in New Brunswick. Due to an inadequate supply of green lumber Northern Lumber closed in the Fall of 2001.

BACKGROUND INFORMATION

Office of Economic Development (OED)

The Office of Economic Development (OED) was created in 2002 when the Department of Economic Development and took over the technology and innovation responsibilities of the defunct Technology and Science Secretariat. The OED was created in order to combine government's role in the economic development making policy with its role in technology and innovation. The goal is to create opportunities for improved support for sustainable productive businesses.

Nova Scotia Business Inc. (NSBI)

Nova Scotia Business Inc. (NSBI) is a provincial Crown Corporation that was created in 2001, in order to provide Nova Scotia with a business focused, private sector led approach to growing the economy. NSBI's goal is to expand business so that there will be sustainable, value-added growth to the economy. This will create employment and also increase revenues to the Province. NSBI has a five-year strategic plan that outlines specific strategies and tactics in order to achieve their goal. NSBI hopes to attract new business, help retain and expand businesses that are already located in Nova Scotia, promote trade and aid companies use of their lending program or providing financial services.

BACKGROUND INFORMATION

The Nova Scotia Woodlot Owners and Operators Association (NSWOOA) was founded in 1969 by a federation of eighteen county woodlot owner organizations across the province. At the time the organizing efforts were based on the need to obtain a fairer, more equitable return for private pulpwood being used by the three major mills. In 1976, small contractors were brought together with woodlot owners under the umbrella of the renamed Nova Scotia Woodlot Owners and Operators Association.

Today, the NSWOOA is an independent organization of woodlot owners and operators having the goal of achieving prosperity, stewardship and solidarity through the practice of ecologically, socially and economically sustainable forestry. This is done through education of members, demonstrations and cooperation.

The NSWOOA promotes the use of low impact forestry as an alternative to today's industrial forestry methods. Low impact forestry emphasizes partial cutting on a regular schedule and provides an even flow of income to woodlot owners. It also promotes a continual improvement to the growing stock, increasing the quantity and quality of the timber resource. Low impact forestry also maintains a continuous forest cover, which provides wildlife habitats, protects water quality and preserves ecological functions.

BACKGROUND INFORMATION

Pork Nova Scotia was created in order to provide the most favourable environment possible for the production and marketing of pork in Nova Scotia and to assist in maximizing returns for Nova Scotia producers. Pork Nova Scotia is the marketing agent for hogs in Nova Scotia. It is mandated to carry out the purchase and sale of hogs in this province through the Natural Products Act. It has an active and organized structure that has become the recognized voice of the Pork Industry in Nova Scotia.

Pork Nova Scotia is organized into 3 geographical zones, representing pork producers who account for 100% of Nova Scotia's pork production. The board of directors consists of six directors, two from each zone. It also maintains active affiliations nationally with the Canadian Pork Council and internationally with Canada Pork International, a member of the Board of Directors of Pork Nova Scotia is appointed to the Canadian Pork Council

The Pork Industry in Nova Scotia is valued at approximately \$30 million at the farm gate and over \$100 million to the Nova Scotia economy. The industry employees over 1500 people in mainly rural communities in Nova Scotia

BACKGROUND INFORMATION

The Department of Transportation and Public Works is responsible for approximately 23,000 kilometres of roadway in Nova Scotia and 4100 bridges. There are approximately 1900 kilometres of 100-series highway. 12000 kilometres of paved secondary roads and 9000 kilometres of gravel roads in Nova Scotia. The Province maintains 90 percent of the road system in Nova Scotia. The municipalities are responsible for the other 10 percent.

In 2001 the department commissioned a study that determined that provincial roads and bridges in Nova Scotia would require \$3.4 billion in capital work be done within the next 10 years in order to maintain them in good working order. Nova Scotia's infrastructure shortfall is approximately \$250 million per year for capital work and costs continue to escalate.

The Department must provide service to taxpayers at the most effective cost in order to be able to stay within budget. One snowstorm alone, such as the 2004 blizzard can cost up to \$3 million. A delicate balance must be maintained.

MATTERS OF DISCUSSION

Maintenance costs for gravel versus, seal-coat versus paved roads;

Road exchange program between the Municipality and the Provincial government, number of provincial highways versus federal highways in Nova Scotia versus other provinces throughout Canada;
Sub-Division Roads, using recycled asphalt, prohibiting the use of salt and creates plowing restrictions, private roads in sub-divisions, Municipal Service Exchange Agreement; Federal Government negotiations for a new agreement, slight possibility of Infrastructure Funds for local paving projects;
Classes of highways, J and K Class; and
Extension of Highway 107 to Sheet Harbour, weather station in Bridgetown, Candy Mountain Road - heavy truck traffic, construction, cost of Ben Jackson Interchange, O'Connell Drive in Porters Lake will go under review, Seal Island Bridge, MacDonald Road, French River guard rail, Whycomomagh to Baddeck,

Nova Scotia Power Inc. (NSPI) is a subsidiary of Emera Inc. NSPI is a wholly owned, fully integrated, regulated electricity utility, with \$3.0 billion of assets, serving 460,000 customers. NSPI supplies over 95% of the electric generation, transmission and distribution in Nova Scotia. NSPI recorded earnings of \$112.1 million, in part due to the utilities first rate increase since 1996.

In 2003 Hurricane Juan caused significant damage to NSPI's infrastructure with an approximate cost of \$12.6 million. (\$4million net operating costs, \$8.6 million in capital costs). Almost 70% of NSPI customers were without power during the hurricane. Over 300 line technicians and 100 tree removal crews worked throughout the state of emergency and restored power to 95% of NSPI customer in 5 days. The other 5% of NSPI customers went as long as 14 days without power

MATTERS OF DISCUSSION

The Committee went into details on the following matters:

Rate increase applications before the Nova Scotia Utility and Review Board, NSPI profits, to shareholders, tax assessments on NSPI properties,
Emera 's other interests - Bangor Hydro Electric Company;
NSPI capacity, need for a new generator, distribution and storage capacity;

MATTERS OF DISCUSSION

NSPI emissions policy especially concerning sulfur dioxide, Kyoto Accord – ratification and compliance, CO2 credits from Russia;

Hurricane Juan, cost of changing to underground power system, tree line reestablishment;

Clearing of transmission lines, hiring of American contractors – possibility of using Nova Scotia sub-contractors;

Auditor Generals 2003 audit concerning the lack of payment to the Province for the radio licensing fees – resolution to the situation;

Tufts Cove power facility, tidal power, conservation and demand-side management;

Renewable Resources – details on the development of wind power resources in Nova Scotia; and three phase power in Cape Breton.

A copy of the Rural and Urban Development Plans from Nova Scotia Power Inc. outlining the installation of power lines between 1982-1992 and then again from 1992–2002.
