The same Honourable Minister then tabled the message from Her Honour the Lieutenant Governor transmitting the Estimates for the consideration of this House; the Consolidated Fiscal Plan for the government consisting of the Government Business Plan and other information contained in the budget; the Crown Corporation Business Plans; the Estimates and Crown Corporation Business Plan Resolutions; delivered the Budget Speech and moved the Estimates of Sums required for the service of the province for the fiscal year ending March 31, 2007, being Supply, to be granted to Her Majesty, and the Crown Corporation Business Plans be referred to the Committee of the Whole House on Supply.

The Honourable Minister then delivered his Budget Speech. A debate arose during which the following took part: Mr. Steele, Halifax Fairview, who adjourned the debate.

SPEAKER'S RULING

"Last night the Member for Cape Breton South rose on a point of privilege. His complaint was that a number of statutes that had been passed during the previous session had not yet been proclaimed by the Executive branch of government.

As I told the House last night, I knew this matter had been raised before and I took it under advisement. The previous occupant of this chair ruled on what was essentially the same point of privilege on April 21st of last year and I have a copy of that ruling, which any Member may have if they wish.

In summary, it is not unusual that statutes are passed subject to proclamation and it is not unusual that they remain unproclaimed for some time while mechanisms and regulations are put in place to support the legislation.

The key point is that is it the Members of this House who <u>choose</u> to pass the legislation subject to proclamation at the discretion of the Executive Council, thereby delegating that authority directly to the Executive Council.

As the previous Speaker noted in the ruling, this is nothing new or surprising and legislation can remain unproclaimed for some time.

Accordingly, I find that there is not a prima facie case of a breach of privilege."
