## SPEAKER'S RULING

"On April 22, 2010, at the end of Oral Questions, three different Members of the House rose on separate points of order. I will refer to them in the order in which they were presented.

The first point of order was raised by the Honourable Deputy Premier. He stated that during Question Period, the Honourable Leader of the Progressive Conservative Party used the word "stole" in the context of "stole the jail". I did examine Hansard and the words as spoken by the Honourable Leader are shown as "when it stole the correction facility". Everyone knows that it would be very difficult to literally commit such an act and the context would suggest a figurative meaning to the word. In as much as some sympathy can be extended here, it still is one of those words that cannot be tolerated, much like "lie" or "liar". I would request that the Honourable Leader to retract that expression.

The second point of order was raised by the Member for Victoria-The Lakes. He stated that the Minister of Tourism, Culture and Heritage had referenced an economic analysis on the impact of the withdrawal of the CAT ferry and thus the analysis ought to be tabled.

Having checked Hansard, I could find no quoting of such an analysis by the Honourable Minister. Therefore there is no obligation to table same and no point of order.

The third point of order was raised by the Honourable Member for Cape Breton South. His point was to the effect that the Minister of Economic and Rural Development gave the impression that he was not going to give the names of individuals on Team West and Team Southwest. Whether the Honourable Minister did or did not give that impression does not constitute or give rise to a point of order.

On Friday, April 23, 2010, the Honourable Member for Cumberland South rose on a point of privilege. The gist of what the Member had to say was that a Minister ought not to absent himself/herself from the Committee of the Whole House on Supply if that Minister's Estimates are on the floor of the Committee. Fortunately Members ultimately have not been subject to an actual loss of time with the chosen

Ministers during this year's Estimates but I do have sympathy for the principle he espouses. If the situation were otherwise, then a Member could be abstracted in his or her rights as a Member in effect. That would amount to a matter of privilege.

Obviously things do come up that are unavoidable. Life does not follow a path of perfection. Difficult situations do happen, planning even months in advance can sometimes bring about an unforeseen consequence. I would caution all Members to utilize the common sense and good will that allows this place to function. If that were to disappear it makes life very difficult for all and especially for your humble servant.
