#### SPEAKER'S RULING

"The Honourable Government House Leader rose on a point of order at the end of Question Period Wednesday, April 28th. He alleged that the Honourable Member for Dartmouth East in quotes 'imputed motive' when he said that the Honourable Minister of Community Services voted for the budget for personal gain.

I checked Hansard and the Honourable Member for Dartmouth East in his first supplementary to the Minister used the words 'maybe if the Minister hadn't voted a tax rebate for herself she would have had more money to give to organizations'.

In the Members second supplementary, the Member used the words 'she could have done more if she hadn't given herself a tax break and that was her choice and her government's choice and what they put money in and they made the wrong choice.'

It is clear that the words of the Honourable Member for Dartmouth East in at least one of his supplementaries made it sound as if the Minister had voted for a singular personal benefit as opposed to a benefit that applied to a much broader class. That would amount to imputing motives or impugning the reputation of a Member. In other words, it would be an unparliamentary expression.

The Member for Dartmouth East, following the point of order raised by the Government House Leader, said in effect that he had 'indicated she (the Minister) voted for a budget which includes a tax break, which obviously in her income she would be beneficial to'. That imputation would be acceptable, I would ask the Honourable Member to withdraw any unparliamentary words and that will be the end of the matter.

Thank you."

A. Younger, Dartmouth East, rose to announce he was withdrawing his remarks and apologized that it resulted in this confusion.
